Submission from the Northern Ireland Business and Human Rights Forum to the Joint Committee's Inquiry on Human Rights and Business

Dear Harnet,

The Northern Ireland Business and Human Rights Forum (NIBHRF) was established in 2015 to help explain how human rights are relevant to business and share information and good practice. The forum's agenda is set by the participants, with support from the Northern Ireland Human Rights Commission. Its membership includes businesses including large and small and medium enterprises, NGOs, trade unions, the Department of Finance and the Department for the Economy.

The NIBHRF seeks to ensure that the UN Guiding Principles are translated into business friendly language accessible to all. Its work plan includes broadening engagement, developing guidance and other practical tools to promote the value of human rights based approaches and to keep forum members updated on what is happening within government and elsewhere in what is a developing area of work.

The NIBHRF has not to date had contact with the cross-Whitehall Steering Group which monitors the UK National Action Plan or the National Contact Point.

The NIBHRF invited representatives from the Foreign and Commonwealth Office (FCO) to come to Northern Ireland in 2015 during the consultation to update the National Action Plan. The FCO did not afford itself of this opportunity.

The International Covenant on Civil and Political Rights (ICCPR), Article 25, and that the UN Human Rights Council (HRC) has stated that 'the conduct of public affairs' extends to 'all aspects of public administration, and the formulation and implementation of policy at international, national, regional and local levels.'1 The UN HRC further provides that '[c]itizens also take part in the conduct of public affairs by exerting influence through public debate and dialogue with their representatives or through their capacity to organize themselves.'2 The UN OHCHR has stated that '[i]nternational human rights instruments and mechanisms acknowledge the right of all people to be fully involved in and to effectively influence public decision-making processes that affect them.'3

UN General Comment 31 on the ICCPR notes that

'A general obligation is imposed on States Parties to respect the Covenant rights and to ensure them to all individuals in their territory and subject to their jurisdiction'4

Many members of the NIBHRF were, and still remain, interested in being involved in consultations on documents which affect business and human rights in Northern Ireland. This is especially true for SMEs who may not have the capacity or resources to attend events in London. Many of our members have taken practical human rights-based approaches to supply chain and other issues and are willing to champion such approaches as being good for business.

The NIBHRF is more than willing to help facilitate events in Northern Ireland on business and human rights to ensure that any resulting documents and policies reflect the views of the people, businesses, organisations, and enterprises in Northern Ireland.
