1. Apologies and Declarations of Interest

2. Minutes and closed minutes (HRC191.1)

4. Chief Commissioner Report (HRC191.2)

- 4.1 The Chief Commissioner reported on meetings and events he had attended since the last meeting. These included:

 - joint roundtable with Equality Commission on equality, human rights and faith issues convened by US Consulate
