# 1. Minutes of the 171<sup>st</sup> Commission meeting

1.1 The minutes of the 169<sup>th</sup> Commission meeting were agreed following amendments to 8.3.

1.2 The minutes of the 170<sup>th</sup> Commission meeting were agreed following the insertion of 'and public authorities' into 6.2.

### 2. Matters arising

2.1 Commissioner Yam's update on his attendance at the CoE-FRA-ENNHRI-Equinet Platform on Hate Crime will be discussed at the June meeting (item 4.1 of previous minutes refers).

- 2.3 Commissioners noted that reference would be made to a long standing legal case in the Commission's forthcoming submission to ICCPR as part of its analysis of the 'On the Runs' (item 7.5 of previous minutes refers).
- 2.4 Commissioners were updated that no decision has been made on the funding application to allow the Commission to chair the of the Commonwealth national human rights forum (item 12.3 of the previous minutes refers).

### 4. Commissioner's Report

4.1 Commissioner McBride reported that he is yet to make contact with the Human Rights Consortium regarding the Human Rights festival (item 4.2 of the previous minutes refers).

### 5. Environment Scanning

- 5.1 Commissioners discussed the environment scanning document and agreed that the approach called PESTEL was the preferred option for their bi-monthly discussions.
- 5.2 Commissioners received a report on contacts with other UK NHRIs to agree a joint statement in response to any emerging Government proposals to replace the Human Rights Act.
- 5.3 Commissioners also agreed to engage with the Irish Human Rights and Equality Commission regarding any potential implications for the Good Friday Agreement and the All-Ireland Charter.
- 5.4 Commissioners agreed to engage with local political parties and the NI Executive regarding the Human Rights Act.

5.5 Commissioners agreed that previous contacts with local political parties around a Bill of Rights for Northern Ireland should be renewed and could include an offer of briefing on the Human Rights Act developments.

- 6.2 The Director reported on the joint work with the NI Ombudsman on a human rights based approach to the work of Ombudsmen including an update on the prospect of an international conference that will be held in Belfast.

- 6.3 The Director gave an update in relation to the application for funding for the Litigants in Person project with Ulster University.
- 6.4 The Director reported that the new permanent researcher Fiona O'Connell had taken up post.
- 6.5 Commissioners discussed the Finance report in detail.

# 7. Proposal for new community engagement

- 7.1 Commissioners discussed the community engagements that have taken place to date.
- 7.2 Commissioners discussed the community engagements going forward and agreed to link the visits to the themes of the strategic plan but also to maintain the practice of meeting with District Council leaders and PSNI.
- 7.3 Commissioners agreed that there should be between 4-6 community engagements per annum.
- 7.4 Commissioners noted that the next community engagement would be to West Belfast on 1 July.
- 7.5 Commissioners agreed that the dates for future community visits would be set in advance.
