A Special Commission meeting was convened to approve the Commission's advice to the Secretary of State for Northern Ireland on a Bill of Rights for Northern Ireland.

The Chief Commissioner welcomed everyone to the meeting and thanked them for their hard work in what had been a very rigorous process. She emphasised the integrity of the process and the involvement of every Commissioner in formulating the advice. Commissioners reflected on the process and expressed their appreciation for the work of the Chief Commissioner on the project.

- 1.1 The Chief Commissioner informed the meeting that they would go through the advice on the Bill of Rights chapter by chapter, and that she would highlight any amendments or changes to the text.
